9. Additional Information is listed below:

- Applicants who are selected for an officer position may be scheduled to take a medical physical (to include a Drug Test and complete the necessary documentation for commissioning.
- Non-prior service officer applicants who are selected for an officer position will be required to sign an enlistment contract if not currently serving in the Air National Guard as an enlisted member, and then attend the Total Force Indoctrination Training (TFIT) for 1 week and attend the Total Force Officer Training (TFOT) for 8 weeks to be commissioned as a 2d Lieutenant.
- Professionals (Doctors, Nurses, Lawyers, Chaplains): Are required to attend a mandatory 5 week Professional Course (Commissioned Officer Training {COT}).
- Prior Service Officers Must be prepared to provide all copies of their Officer Performance Reports (OPR's), most current Record Review Listing, copy of last medical physical (specifically AF Form 422 and Web HA), Flying records (if applicable), appointment and Promotion order(, DD Form 214 and any other separation document(s). Current physical fitness evaluation results must also be submitted. If currently assigned to another military unit, a Conditional Release must be initiated by you and signed/approved by proper authority.
