III. GUIDELINES

Tours of the Illinois Air National Guard's 182nd Airlift Wing are free and last about two hours. Your tour guide will meet you at the base's Main Gate and escort you during your visit. You may be required to exit your vehicle for a routine vehicle search before entering the base, so carpooling is encouraged. Please ensure there are no guns, knives, other weapons, illegal drugs, or any contraband in the vehicles or in anyone's possession.

Tours may be canceled for hazardous weather (e.g., thunderstorms, lightning within five miles, winter storms, wind chill advisories, etc.). You will be notified as soon as possible and the tour can be rescheduled. Please wear appropriate clothing, such as comfortable clothes and tennis shoes. **You will be walking a great deal outdoors. For security purposes, bus drivers are required to either join the tour or depart base until pickup time.**

*It is imperative that guests stay with the tour guides. Adults must maintain control of minors at all times, to include remaining orderly in the work areas. Accordingly, we require that there be at least one adult present for every 10 minors under the age of 10, and one adult for every 15 minors ages 10 through 17. Children are not permitted to run around in the work areas for safety and security concerns. **Noncompliance will lead to the tour ending.***

You will get to see the following during your tour:

Fire Department – Trucks, gear, and fire safety.
 Aircrew Flight Equipment shop – Night vision, parachutes, aircrew survival gear, etc.
 C-130H3 Hercules – The aircraft used in the 182nd Airlift Wing's missions.
